# **Application for Amateur Radio Club Licence**

#### **General Guidelines**

Amateur Radio Club license is issued to a bonafide Amateur Radio society, club or a school, college, or an institution or a university in India, which has the aim of investigations in the field of radio or the training of persons in radio communication techniques without pecuniary interest.

The license shall be issued in the name of an authorized official of the society, club, school, college, institute or a university in India holding an Amateur Radio license. The applicant must not have any other club license in his/her name.

**License fee:** Rs. 1000/- for 20 years (or till validity of licence the custodian)

# The following documents are to be submitted:

- 1. Covering Letter
- 2. Application for club licence in the prescribed format.
- 3. Attested copy of birth certificate of the custodian of the club (General Grade Licence holder). (The name of attesting officer must be given.) Ration Card, Voter Id. PAN Card, Driving Licence etc. is not accepted.
- 4. Nationality certificate of the custodian of the club. (The name of signing officer must be given.)
- 5. Two stamp size photographs of the custodian of the club.
- 6. Crossed Demand Draft for Rs.1000/- from any Nationalised Bank in favour of 'PAO (HQ), D.O.T' payable at New Delhi.
- 7. Copy of constitution of the club.
- 8. Minutes of relevant meeting.
- 9. Copy of Amateur Radio licence / Renewal card of custodian of the club.
- 10. Self declaration and licence copy & renewal copy of 5 members of the club (if available).
